Public-source-verified commercial product designation for international B2B review

Public-source-verified identity. Corporate disclosures of Iron & Steel for Mines & Quarries identify El-Gedida Mine export iron ore at 58% grade and record crusher-produced iron ore at the same nominal grade. This TAS document preserves that public commercial identity; it is not a producer-issued COA, specification, authorization or supply confirmation.

Published designation

El-Gedida Mine iron ore - export 58% grade.

Physical position

Crusher-produced / crushed iron ore for bulk commercial evaluation.

Mine reference

El-Gedida Mine, Bahariya Oasis, Egypt - subject to current origin and supplier documents.

Acceptance basis

Current COA, approved sample, sieve analysis, contract and agreed inspection.

Buyer control principle

Only the published product designation and nominal grade are carried forward as source-aligned facts. Every chemistry, size, origin, availability and shipment value must be controlled by current transaction documents.

COMMERCIAL SCOPE

What this reference can and cannot establish

- It can establish that public company disclosures use a 58% export / crusher-product designation.
- It cannot establish current stock, producer authorization, agency, exclusivity, mine ownership or endorsement.
- It cannot replace a representative sample, current laboratory report, inspection certificate or signed sales specification.
- It should be used to structure a serious buyer inquiry and the documents required before quotation or acceptance.

COMMERCIAL POSITIONING

How the nominal 58% grade should be presented

Higher nominal-grade crushed iron ore for export trading, blending and steel-feed or mineral-processing evaluation. The 58% designation alone does not confirm gangue limits, reducibility, sintering behaviour or direct metallurgical suitability.

01 - Representative sample

Obtain a traceable sample tied to the offered stockpile, lot or shipment.

02 - Current laboratory analysis

Confirm Total Fe, gangue, deleterious elements, moisture and LOI using an agreed method.

03 - Size and inspection

Agree particle-size limits, sampling, weighing, stockpile identification and third-party inspection.

04 - Contract controls

Fix tolerance, price adjustments, rejection rules, Incoterm, payment, document hierarchy and claim procedure.

MINIMUM COA DATASET

Values to request for every offered lot or shipment

- Total Fe and laboratory basis; Fe₂O₃ equivalent only when calculated or directly reported.
- SiO₂, Al₂O₃, Mn or MnO, P or P₂O₅, S or SO₃, CaO and MgO.
- BaO, TiO₂ and chloride when commercially or technically relevant.
- Moisture, loss on ignition, test method, laboratory name, sample ID and analysis date.
- Particle-size distribution, oversize, undersize and sampling standard.

SUPPLY AND LOGISTICS CONFIRMATION

Commercial controls before quotation

Item	Required confirmation
Available quantity	Current stock and monthly supply capacity
Packing / shipment	Bulk, bags or other arrangement according to the offer
Loading point	Exact mine, stockyard, rail, truck or port delivery point
Inspection	Sampling, weighing and inspection company agreed in writing
Origin documents	Current certificate of origin and producer/supplier chain
Commercial terms	Price basis, currency, Incoterm, payment and lead time

**BUYER RFQ CHECKLIST**

Information needed for a serious 58% grade inquiry

- Required nominal grade: 58% and acceptable Total Fe tolerance.
- Full chemistry limits and price adjustment / rejection schedule.
- Required particle-size range and oversize / undersize tolerance.
- Quantity per shipment, monthly program and destination port or delivery point.
- Preferred Incoterm, payment terms, inspection company and shipment timing.
- End use and any process-specific test or mineralogical requirement.
